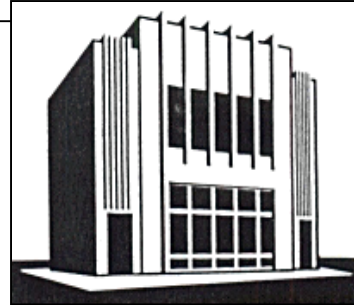

## LAWNDALE ARTIST REGISTRY AGREEMENT

1. The Registry File will remain active for one year from date of registration.
2. Artist agrees that the complete Registry file will be made available to the public free of charge and will remain available until the end of the Registry period.
3. Registry may be accessed in person by appointment only or through Lawndale's website.
4. Only the artist may remove their materials.
5. Artist is responsible for updating physical files and may do so as needed by appointment.
6. Artist is responsible for renewing registry at deadline with a new membership. Artist is responsible for picking up all materials or for arranging retrieval at the end of the term. Otherwise, materials will be held for one month only and then destroyed.
7. Lawndale will not mail registry contents to anyone.
8. Lawndale will not broker sales.
9. Lawndale will not make copies of slides.
10. Lawndale *will* make copies of statement, resume and bio for a small fee to cover costs.

The Artist hereby warrants that he/she has full legal title to all Works described in the Registry or any of the attachments or that he/she is the duly authorized agent of the owners of said Works. The Artist hereby agrees to indemnify Lawndale and hold it harmless from any liability for costs, expenses, or damages (including any attorney's fees or other costs of defending against claims by individuals, institutions, or other entities claiming full or partial title to any of said Works).

Under this agreement, Lawndale will exercise the same care with respect to the Registry that it would in safekeeping its own property. The terms of this agreement are subject to alteration as a result of unforeseen circumstances brought about by emergencies or any eventually beyond the control of Lawndale's function.

This agreement shall be binding upon the heirs, executors, administrators, personal representatives, successors and assigns of the Artist and/or Owner. This Agreement constitutes the entire agreement of the parties and no verbal or prior understanding or promise shall be effective unless contained herein or subsequently agreed to in writing by the parties.
